



Sub: Permanent Affiliation under RTE Act 2009.

In respect of the above subject, you are informed that you have been issued a permanent affiliation on the basis of the following conditions under the RTE Act 2009 and are informed that if any deficiency is found during the checking by this office or by the higher officials of the department from time to time, then this issued affiliation will be canceled without informing you. The school management shall be bound to comply with the following amendments of RTE Act as may be made by the Government from time to time:-

- (1) This affiliation is issued in continuation of the provisional affiliation issued before 01-04-2016. This affiliation will not be applicable above class VIII.
- (2) The school shall comply with the provisions of the Right of Children to Compulsory and Free Education Act, 2009, Annexure (1), and Annexure (2).
- (3) According to 25% of the total number of students in the classes, the school will admit the weak and backward students from its surroundings in the first class and provide free and compulsory primary education till the completion of their primary education and follow these rules also in the pre- primary classes as necessary.
- (4) In respect of children referred to in paragraph 3, reimbursement shall be made to the school in terms of section 12(2) of the Act and a separate bank account shall be provided to the school to receive the reimbursement.
- (5) The school or institution shall not collect any kind of capitation fee and shall not interview the child or his parent/ guardian.
- (6) The school will not deny admission to the following:-
 - In case of no proof of date of birth;
 - In extended period after date of admission;

- Based on religion, caste, place of birth.
- (7) Schools should ensure:
- (a) No child shall be held back in any class nor shall his name be excluded from school till the completion of primary education.
 - (b) No child shall be subjected to corporal punishment or mental harassment.
 - (c) No child is required to appear for the board examination till completion of primary education. But if the Punjab government makes any amendment in it, then the organization will be bound to accept it.
 - (d) As mentioned in Rule 23, every child who completes primary education shall receive one of its certificate.
 - (e) Inclusion of children with special needs in accordance with the provisions of the Act.
 - (f) To recruit teachers having the minimum qualification specified under section 23(1) of this Act and if a teacher does not possess the minimum qualification at the commencement of this Act, he shall acquire it within five years.
 - (g) To perform the duties specified in section 24(1) of this Act by the teacher.
 - (h) The teacher shall not engage in any kind of private teaching activities.
- (8) Syllabus will be conducted by the school based on the curriculum drawn up by the appropriate authority.
- (9) Children should be admitted to the school only in accordance with the distribution of facilities available in the school as per Section 19 of the Act.
- (10) The school shall maintain its standards and regulations as specified in section 19 of the Act.
- (11) Unrecognized classes will not be conducted inside the school nor outside the school in the name of the school.
- (12) The school building or other construction or playground shall be used only for the purpose of education.
- (13) Schools are run by institutions registered under the Institutions Registration Act, 1860 (21 of 1860) or under the law of the time being in public interest.
- (14) The school is not run for the profit of any individual, group or association or any other person.

- (15) Genuine statement of accounts should be prepared as per rules. Account should be audited and verified by CA. A copy of the statement of each account should be sent to the District Education Officer (E.E.) every year.
- (16) The affiliation given to your school will remain the same. This number should be used for further communication with our office.
- (17) The school shall furnish reports and information as required by the District Education Officer/ Director of Education from time to time and shall comply with the conditions for remedying the deficiencies in the functioning of the school or maintaining the fullness of accreditation issued by the State Government/ Local Authority.
- (18) Renewal of organization registration, if any.
- (19) It is mandatory to get a certificate every year regarding the school data computerized completion from the MIS branch in District Education Officer (E.E.) Shaheed Bhagat Singh Nagar.
- (20) It should be ensured that fire safety and building safety certificates are obtained from the concerned departments and renewed immediately on expiry and a copy of this certificate should be delivered to the office of District Education Officer (E.E.) Shaheed Bhagat Singh Nagar.
- (21) In case there are buses in the school, the school management shall be bound to keep these buses and other means of transport updated as per the instructions issued by the Hon'ble Punjab and Haryana High Court, Chandigarh and Punjab Government.
